NOTICE OF PROPOSED AGENCY ACTION  
ORDER APPROVING TRANSFER OF CONTROL OF ALL  
OUTSTANDING COMMON STOCK

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated July 7, 1999, Onyx Distributing Company, Inc. d/b/a Florida Comm South (Florida Comm South) and Topp Telecom, Inc. (Topp Telecom) filed with this Commission an application for approval of transfer of control of all outstanding common stock from Florida Comm South to Topp Telecom. Florida Comm South is the holder of Alternative Local Exchange Telecommunications Certificate No. 4757. Florida Comm South has stated that the transaction will be virtually transparent to its customers in Florida and it will not affect the services being provided. Florida Comm South has further stated that it will continue to operate under its existing certificated name and tariff on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of Florida Comm South and Topp Telecom, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. Our decision does not address the potential impact of the transfer on the competitive market in Florida, or on the companies' or their competitors' interests. We emphasize, however, that our approval of the Petition pursuant to our authority under Section 364.33, Florida Statutes, does not preclude us from addressing any of our concerns that may arise regarding this transaction to the appropriate federal or state agencies.

Based on the foregoing, it is,


ORDERED by the Florida Public Service Commission that Onyx Distributing Company, Inc. d/b/a Florida Comm South and Topp Telecom, Inc.'s request for approval of transfer of control of all outstanding common stock from Onyx Distributing Company, Inc. d/b/a Florida Comm South to Topp Telecom, Inc. is hereby approved. It is further
