Dear Mr. Cawal:

According to our records, River Ranch failed to timely file its 1998 Annual Report by its extended due date of June 30, 1999. Rule 25-30.110(6) and (7), Florida Administrative Code, sets penalties for noncompliance with the annual report requirement. The applicable penalty for a Class C is \$3.00 per day and is based on the number of calendar days elapsed from the due date until the date of filing. We have also noticed that the utility did not respond to our letter on April 29, 1999, which required the utility to pay a penalty of \$78.00 due to the delayed request for the extension. Therefore, it is imperative that the utility promptly file the 1998 annual report as well as a check made payable to the Florida Public Service Commission for the amount of the penalty. The payment of the penalty should be mailed to: Bureau of Fiscal Services, Florida Public Service Commission, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, ATTN: Evelyn Sewell
