Haus Development, Inc., by and through its undersigned president, hereby concurs to the Motion to Expedite Hearing on the above mentioned dockets as filed by Lake Suzy Utility for the following reasons:

1. This matter was originally scheduled for Final Hearing on January 13 and 14, 1999, but was continued when Lake Suzy and Florida Water Services Corporation believed they had reached a settlement.
2. On May 14, 1999, Lake Suzy advised the Commission that settlement was not accomplished and requested that the matter be set for final hearing as soon as possible.
3. Haus Development would be prejudiced by the rescheduling the hearing until February, 2000 because Haus Development owns 41 of the 49 lots of the Links Subdivision, and in the process of trying to sell these lots.
4. Haus Development has been waiting **very patiently** for a formal hearing in this matter. Lake Suzy and Charlotte County had entered an agreement on **December 9, 1997** to provide utilities to the Links Subdivision. Haus Development is satisfied with this arrangement.


