At the September 7, 1999 Agenda Conference, the Commission approved Staff's recommendations to fine or cancel the certificates of the above referenced companies for violation of Rule 25-24.0161, Florida Administrative Code. Each of the above referenced companies contacted Staff on the date of the Commission's vote and made settlement offers to resolve this matter. Staff will be filing recommendations for the October 5, 1999, Agenda Conference to address the companies' settlement offers.

For the reasons described above, the Orders imposing fines and requiring payment of the required Regulatory Assessment Fees or canceling Pay Telephone certificates, due to be filed on September 27, 1999, will not be issued. Upon the disposition of this matter on the October 5th Agenda, an order consistent with the Commission's decision will be issued for these dockets.
