COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification.

1. On September 2, 1999 the Staff of the Florida Public Service Commission (the "Staff") served its First Set of Interrogatories and First Request for Production of Documents to BellSouth. On September 13, 1999, BellSouth filed its General Objections to that discovery.
