On behalf of our client, Ionex Telecommunications, Inc., we submitted a letter dated September 27, 1999 notifying the Florida Public Service Commission, that, for purposes of the above-captioned application, Ionex Telecommunications, LLC "has become" Ionex Telecommunications, Inc. We write to clarify that the paperwork creating Ionex Telecommunications, LLC was never completed by corporate counsel. Before that paperwork was finalized, a decision was made instead for Ionex Telecommunications, Inc. to be the company proposing to acquire Telecom Resources, Inc. Accordingly, Ionex Telecommunications, Inc. should be substituted for Ionex Telecommunications, LLC for purposes of this application.

_____ This clarification does not change any other information provided in the initial application, or in our recent letter alerting the Florida Public Service Commission to minor revisions to Ionex's corporate structure. The ownership of Ionex Telecommunications, Inc. remains unchanged. The illustrative organizational chart in our recent letter continues to reflect the corporate structure of the Applicants prior to and immediately following the transfer of control. For your convenience, another copy of that chart is attached hereto.¹

¹ In addition, Ionex hereby notifies the Commission that Thomas Kessler, identified as Chief Marketing Officer of Ionex in the application, is no longer an Ionex officer.
