Please be advised that PNV.net, Inc. formerly known as Park 'N View, Inc., has engaged in the following financing transactions:

A. In September of 1999, Applicant sold an aggregate of 3,000,000 shares of Series D preferred stock for \$31.5 million. In connection with the closing of the sale of Series D preferred stock, the company entered into certain amendments to the agreements with various holders of the company's Series A, Series B and Series C preferred stock.

B. On September 17, 1999, Applicant filed a Form S-1, Registration Statement Under the Securities Act of 1933, with the Securities and Exchange Act. Upon the effective date of the registration statement, the Applicant intends to sell to the public, an aggregate of \$60,000,000 shares common stock with a par value of \$.001 per share, at a price which is yet to be determined. The Applicant intends to use the net proceeds of the offering to redeem its Series A preferred stock, fund operating losses and capital expenditures, and for working capital and other general corporate purposes.

Since there is no transfer of control, Commission approval should not be necessary. If any further action is required on our part, please advise us, and we will act accordingly.


