



**TAMPA ELECTRIC COMPANY'S
MOTION FOR ONE-DAY EXTENSION OF TIME**

Tampa Electric Company ("Tampa Electric" or the "company") pursuant to Rule 28-106.204(5), Florida Administrative Code moves the Commission for a one business day extension of time through and including Monday, November 1, 1999 within which to file Rebuttal Testimony of Tampa Electric Witness Thomas L. Hernandez and as grounds therefore says:

1. This motion pertains only to the Rebuttal Testimony of Mr. Thomas L. Hernandez.
2. Mr. Hernandez' testimony addresses the direct testimony of FIPUG's witness Kent D. Taylor, Staff's witness Judy Harlow and Office of Public Counsel's witness David E. Dismukes. Tampa Electric has been granted a one-day extension of time to file rebuttal testimony addressing Mr. Taylor's testimony.
3. Tampa Electric is in need of the one-day extension to file rebuttal testimony addressing the testimony of Ms. Harlow and Mr. Dismukes as well, given the press of depositions, expedited discovery and other regulatory activities that have crowded the calendar even beyond a normally busy schedule.

4. Tampa Electric has conferred with counsel with FIPUG and OPC who have indicated no objection to the one-day extension. Tampa Electric has attempted to contact counsel for the Commission and left a voice mail but has not been able to make contact regarding this request.

WHERE, Tampa Electric Company requests a one business day extension of time through and including Monday, November 1, 1999 in which to file Rebuttal Testimony of Tampa Electric's Witness Thomas L. Hernandez in this proceeding.


