

MOTION FOR RECONSIDERATION

BELLSOUTH TELECOMMUNICATIONS, INC., ("BellSouth"), pursuant to Rule 25-22.060, Florida Administrative Code, hereby seeks reconsideration of Order No. PSC-99-2185-FOF-TL, issued on November 8, 1999, for the following reasons:

1. At the October 20, 1999 Agenda Conference, the Florida Public Service Commission ("Commission") considered an Emergency Request for Extension of the Permissive Dialing Period until April 1, 2000 filed by ADT Security Services, Inc. ("ADT").

2. At the Agenda Conference, BellSouth stated that, if the extension were granted, it would be necessary to provide a permissive dialing extension to the majority of the NXXs in the overlay area.

3. BellSouth's statement was incorrect. If the extension were granted, the Commission would need only to grant an extension for the 10-15 NXXs that contain an ADT telephone monitoring number. Because the Commission may have relied on BellSouth's incorrect statement to deny ADT's request for extension, BellSouth requests that the Commission reconsider its decision and provide ADT an extension.

4. BellSouth proposes that ADT focus its efforts on the conversion of the security systems of non-BellSouth customers to 10 digit dialing prior to the December 1, 1999 mandatory date. BellSouth will extend the permissive dialing period for the 10-15 NXXs within BellSouth's service territory that contain ADT monitoring numbers until April 1, 2000. This proposal provides ADT with the requested relief and allows other carriers to receive numbering resources because the NXXs not containing ADT numbers will be available for assignment.


WHEREFORE, BellSouth requests that the Commission consider this Motion prior to the December 1, 1999 mandatory date and grant the relief sought herein.
