4.1 Directory Assistance

4.2 Switched Access Services:

Interexchange Carriers wishing to receive InterState-InterLATA toll/800 calls from or terminate toll/800 calls to OTC customers will use Switched Access Service. OTC will provision a sufficient quantity of trunking facilities to insure a minimum P.001 grade of service.

The charges for originating and/or terminating InterState-Interlata calls in LATA 458, NPA-NXX 407-995, 407-996, & 407-997 is \$.082916 per minute of use.
