Re: Notification of Transfer of Control of Foxtel, Inc. Common Stock to AMI Telecommunications Acquisitions Corporation; Florida Certification No. 5318.

Dear Ms. Bayo:

This letter is sent on behalf of Foxtel, Inc. ("Foxtel" or "Company") as notification to the Florida Public Service Commission that Foxtel has entered into an agreement to become a wholly-owned subsidiary of AMI Telecommunications Acquisition Corporation ("AMI"), which is to become effective no sooner than the date upon which all necessary orders, consents and approvals by the regulatory authorities having jurisdiction over the Company are received. No changes are required to the Certificate of Foxtel as the Company will not merge with AMI, but will remain a separate entity.

Foxtel, Inc. is currently 100% owned by Vacation Technology Services, Inc., whose sole owner is Morris Jacobs. Under the terms of the agreement, a new company, AMI Telecommunications Acquisition Corporation, will acquire 100% of the shares issued and outstanding of Common Stock of Foxtel, Inc. from Vacation Technology Services, Inc. AMI Telecommunications Acquisition Corporation will, at a later date and following the transaction, change its name to AMI Telecommunications Company, Inc. AMI is *not* a provider of telecommunications services, and is not certificated in any state.

This transfer of stock will result in a stronger financial position from which to continue providing quality service options to customers of Foxtel.

This transaction will be transparent to the Customers of Foxtel, Inc. as there will be no interruption of service or change in the management or operation of the Company. The transfer of control will have no effect on the Company name, address, contact information, services, rates or terms and conditions of service. The Company will continue to market, brand and bill in the same name.
