## JOINT MOTION TO REVISE SCHEDULE AND HEARING DATES

Nocatee Utility Corporation ("Nocatee") and Intercoastal
Utilities, Inc. ("Intercoastal") hereby jointly move the
Commission to revise the schedule for further proceedings in this
docket, including a change in hearing dates. In support thereof,
the parties state:

- 1. Nocatee's application for a multi-county water and wastewater certificate to serve proposed territory in Duval and St. Johns Counties was filed on June 1, 1999.
- 2. Intercoastal's objection to Nocatee's application was filed on June 30, 1999.
- 3. On August 16, 1999, the Commission entered Order No. PSC-99-1603-PAA-WS denying Nocatee's petition for temporary variance from or temporary waiver of a number of Commission rules. The effect of this order, which Nocatee did not protest, is to require Nocatee to prepare and submit the detailed information necessary to set initial rates in this docket.
- 4. On September 9, 1999, the Prehearing Officer entered Order No. PSC-99-1764-PCO-WS establishing procedure and setting

dates for the activities in this docket. By Order No. PSC-99-1934-PCO-WS, the Prehearing Officer granted Nocatee's unopposed motion to change the testimony filing dates. That Order made no change in the originally scheduled May 9-10, 2000 hearing dates.

- 5. On October 12, 1999, NUC withdrew its then pending motion to dismiss Intercoastal's Objection. Intercoastal has stated its intention to file an application with the Commission for a multi-county certificate to serve the territory covered by Nocatee's application.
- 6. Intercoastal currently plans to file its application during December, 1999. Intercoastal intends to ask the Commission to consolidate its application docket with this docket.
- 7. Nocatee and Intercoastal have agreed that under the circumstances, it is beneficial to both parties to reschedule future activities in this docket, including the hearing dates. Based on indications from the Commission Staff that the next available hearing dates would be in August or September, 2000, the parties propose the following schedule. The parties request that the same schedule be applied to both the current docket and to Intercoastal's upcoming certificate docket:

8. The parties note that if this docket is consolidated for hearing with Intercoastal's upcoming certificate application docket, the final hearing may require three days, rather than the two days currently alloted.

WHEREFORE, Nocatee and Intercoastal request that the Commission revise the schedule for this docket as set forth in the body of this motion.
