COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and files its Notice of Intent to request a temporary waiver of the collocation requirements in the Mandarin-Loretto central office pursuant to Order No. PSC-99-1744-PAA-TP issued September 7, 1999.

1. BellSouth is unable to provide collocation in this office due to the lack of space. Currently, BellSouth has plans to complete a building addition in this office sometime in the second quarter of 2000. Once the addition is complete, there will be sufficient space to provide requesting ALECs collocation in this office.

3. BellSouth will file its petition for waiver 20 days from the date of this filing.
