This is a follow up to our telephone conversation concerning the past due regulatory assessment fees (RAFs), including statutory penalty and interest charges. Currently, if your payment for the 1998 RAF is postmarked by November 30, the past due amount is \$67.50 (\$50.00 fee, \$12.50 penalty, and \$5.00 interest). If your payment is postmarked in December, the interest increases to \$5.50, for a total due of \$68.00. The 1998 RAF form is attached, which should be completed and returned.

Since you stated you had never installed a pay telephone and wanted your certificate canceled, you should first pay the past due amount and write the Commission a letter. Your letter should include the docket number, state that the past due amount has since been paid (after you have done so, of course), state when you will pay the 1999 fee (it becomes due January 31, 2000, however, you can send that payment with your 1998 payment if you wish), and request voluntary cancellation of your certificate. After your payment and letter is received requesting voluntary cancellation, I will take another recommendation back to the Commissioners and recommend that your certificate be voluntarily canceled. At that point, the \$500 fine would not be assessed. Any letter should be addressed to Ms. Blanca Bayó, Director, Division of Records and Reporting, Florida Public Service Commission, at the above address.

I hope this has been responsive to your call. If you have any other questions, please let me know.
