Issue 1: Should the Commission approve the negotiated agreements and amendments to agreements between BellSouth Telecommunications, Inc. and Best Pre-Paid Telephone Company, Inc.; BellSouth Telecommunications, Inc. and Alliance Telecommunications, Inc.; BellSouth Telecommunications, Inc. and Convergence, Inc.; BellSouth Telecommunications, Inc. and Computer Business Sciences, Inc.; BellSouth Telecommunications, Inc. and OptiLink Communications, Inc.; BellSouth Telecommunications, Inc. and State Communications, Inc.; and BellSouth Telecommunications, Inc. and Omnicall, Inc.?

Recommendation: The Commission should approve in part the negotiated agreements and amendments to agreements, but should reject those provisions set forth in the analysis portion of staff's November 18, 1999 memorandum that discriminate against telecommunications carriers not a party to the agreements. Staff believes the implementation of the agreements as written is not consistent with the public interest and violates Section 252(i) of the Telecommunications Act of 1996.
