FIPUG'S POST- HEARING STATEMENT OF ISSUES AND POSITIONS

The Florida Industrial Power Users Group (FIPUG), through its undersigned attorney, in accordance with the Order Establishing Procedure rendered in this docket, hereby files its Post-Hearing Statement of Issues and Positions. FIPUG adopts its prehearing positions on all issues except Issue 19J which reads:

ISSUE 19J: Should the Commission approve Tampa Electric Company's proposed regulatory treatment for its wholesale power supply agreement with Florida Municipal Power Agency for January 1, 2000 through March 15, 2001?


FIPUG: *From evidence adduced at hearing, FIPUG withdraws its objection to TECo's proposed treatment of revenues for the period 2000 through March 15, 2001 and adopts it. TECo's proposal provides greater benefit to all customers during that time period than plant separation or the post- hearing proposal of the Commission Staff.*
