COMES NOW US LEC of Florida Inc. ("US LEC") and BellSouth Telecommunications, Inc. ("BellSouth"), through counsel, and file this Consented Motion to Extend Times for Filing Testimony, stating as grounds therefor the following.

1. US LEC and BellSouth have agreed to work together to reach a stipulation of facts in order to limit the scope of the hearing or perhaps to avoid the need for hearing.

2. Presently, direct testimony is to be filed on December 20, 1999, and rebuttal testimony on January 31, 2000, with the hearing set for April 17, 2000.

3. In order to create a period of time before testimony must be filed in which US LEC and BellSouth can pursue such a stipulation, it is hereby jointly requested that the Prehearing Officer issue an amended procedural order setting January 31, 2000, as the filing date for direct testimony and February 18,
