
Re: Approval of an Amendment to the Interconnection Agreement Negotiated by BellSouth Telecommunications, Inc. ("BellSouth") and Computer Business Sciences, Inc. pursuant to Sections 251, 252 and 271 of the Telecommunications Act of 1996

Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and Computer Business Sciences, Inc. are submitting to the Florida Public Service Commission an amendment to their negotiated agreement for the interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to Computer Business Sciences, Inc. The Commission approved the initial agreement between the companies in Order No. 98-1166-FOF-TP issued August 27, 1998 in Docket 980626-TP.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting the negotiated agreement between BellSouth and Computer Business Sciences, Inc. within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity. Both parties aver that neither of these reasons exist as to the agreement they have negotiated and therefore, are very hopeful that the Commission shall approve their agreement.

AMENDMENT
TO
THE INTERCONNECTION AGREEMENT BETWEEN
COMPUTER BUSINESS SCIENCES, INC.
AND
BELLSOUTH TELECOMMUNICATIONS, INC.
DATED APRIL 13, 1998

Pursuant to this Agreement (the "Amendment"), Computer Business Sciences, Inc. and BellSouth Telecommunications, Inc. ("BellSouth") hereinafter referred to as the "Parties", hereby agree to amend the Interconnection Agreement between the Parties dated April 13, 1998 ("Interconnection Agreement").

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. Paragraph 16.1 of the General Terms and Conditions (Part A) is hereby deleted in its entirety and shall be replaced with the following:

16.1 BellSouth shall make available to Computer Business Sciences, Inc. any interconnection, service, or network element provided under any other agreement filed and approved pursuant to 47 USC § 252.

2. All of the other provisions of the Interconnection Agreement shall remain unchanged and in full force and effect.

3. Either or both of the Parties is authorized to submit this Amendment to the Florida State Public Service Commission or other Regulatory Agencies for approval subject to Section 252 (e) of the Federal Telecommunications Act of 1996.
