Section 23 (Township 26 South, Range 16 East - Sheet No. 109) - This first map shows the location of the two territories proposed for addition to Aloha's existing service territory and their relationship to the existing territory and existing facilities of Aloha. On the Eastern side of this map you will note Seven Springs Boulevard, which is the current Western edge of the Aloha Seven Springs service territory in this area. You will also note that there is an existing 8" water main going into the Riviera subdivision (which is already served) and within 200 feet of the Blackwell property.


Section 32 (Township 26, South, Range 16 East - Sheet No. 108) - This map, which is immediately to the West of the previous map, shows the Western end of the Riviera property and its relationship to the Anclote River and Forest Hills' service territory. As you can see, the river separates Forest Hills' certificated service territory from that proposed for service by Aloha.

In addition, attached is a copy of the transmittal letter received from the engineer. I forwarded onto the engineer copies of the Orders granting Forest Hills its Original Certificate and its one extension, and he has reviewed those and compared them to the territory requested for extension by Aloha and to Aloha's existing service territory. As you can see after review of those legal descriptions and the legal descriptions submitted to the PSC, he has reached the conclusion that there is no overlap between the two.

I trust that the attached maps (3 copies of which are attached) and the engineer's explanation adequately outline the exact location of the territory requested for service, the facilities adjacent thereto, and all of its relationship to the Forest Hills' property. Should you have any further questions with regard to those issues, please let me know.
