



Gulf has requested confidential treatment of certain portions of its response to Staff Interrogatories #1 and #17, Document No. 05936-99 (cross-reference Document No. 04092-99, which includes all other confidential discovery already returned to Gulf). Interrogatory #1 contains specific revenue requirements information submitted to Gulf by third parties in response to Gulf's Request for Proposals (RFP). The information contained in this document is treated as confidential by those third parties and, in turn, by Gulf at their request. Disclosure of this information may cause the third parties to refrain from participating in future RFP processes in Florida. This may result in a less robust market which could cause higher prices at the expense of Gulf's ratepayers. Interrogatory #17 contains fuel costs associated with each selfbuild option and each RFP project. The information contained in this document is considered proprietary by Gulf since knowledge of specific prices paid for natural gas and transportation services puts Gulf at a disadvantage during negotiations.

Staff concurs with Gulf's request and recommends that the desired information be granted confidential status and remain confidential for a period of eighteen months from the date of the request in accord with Section 366.093(4), Florida Statutes.




