On March 8, 1999 and March 11, 1999, when copies of certain portions of staff's audit report and working papers regarding "Bidding Naples Rock Conditions" were delivered to the FPL at the audit exit conference, the utility requested that these documents be temporarily excepted from public access in accordance with the provisions of Rule 25-22.006(3)(a)(2), Florida Administrative Code (FAC). On March 17, 1999, staff filed documents 03218-99, 03219-99, 03220-99, 03221-99, and 03222-99 consisting of those specified portions of the audit report and working papers. These documents are currently held by the Division of Records and Reporting and designated as temporarily exempt from public access.

On March 17, 1999, the utility filed a request pursuant to Rule 25-22.006, FAC, and Section 366.093, Florida Statutes (F.S.), that selected portions of the staff audit report and working papers prepared by staff during the audit receive confidential classification. The utility's request included highlighted copies (03455-99) and redacted copies (Exhibit B, Document 03454-99) for public use.

Pursuant to Section 119.07, F. S., documents submitted to this Commission are public records. The only exemptions to this law are specific statutory exemptions and exemptions granted by governmental agencies pursuant to the specific terms of a statutory provision. Subsections 366.093(3)(b)(d) and (e), F.S., provide the following exceptions:

"Proprietary confidential business information means information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the person's or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public. Proprietary confidential business information includes, but is not limited to:....

- (b) Internal auditing controls and reports of internal auditors....
- (d) Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms.
- (e) Information related to competitive interests, the disclosure of which would impair the competitive business of the provider of the information....”

According to Section 366.093, F. S., and Rule 25-22.006, FAC, the utility has the burden of demonstrating that materials qualify for confidential classification. According to Rule 25-22.006, FAC, the utility must meet this burden by demonstrating that the information is proprietary confidential business information, the disclosure of which will cause the utility, the provider of the information or the ratepayer harm.

#### **Staff Analysis of FPL's Request**

Analysis of the utility's request and listing of confidential materials reveals the sensitive information presented in the filing consists of:

##### **1) Internal Audit Reports**

FPL witness Del Cueto, FPL Manager, Internal Auditing, attests that the materials in this filing contain or constitute “....internal auditing controls and reports of internal auditors or information relating to same....”

##### **2) Contractor competitive bid submittals**

##### **3) FPL summaries of contractor bids**

##### **4) Purchase order numbers**

##### **5) Other contractual data such as pricing and other terms, payment records and contractor rates.**

According to the utility, “Disclosure of this information would impair the efforts of FPL to contract for joint trenching services on favorable terms and/or impair the competitive interests of the contractors.” For example, witness Bromley, FPL Manager, Regulatory Strategy, Distribution Business Unit, indicates in his deposition, Document 03456-99, Exhibit D; “...the disclosure of project-specific purchase order numbers might enable a contractor's competitor to improperly obtain from FPL contractual data relative to specific contracts or other contractors.”



### **Staff Recommendation**

Based upon review of the sensitive materials presented in this filing, we recommend the materials be granted a confidential classification on the basis that the materials disclose (1) either internal auditing controls or internal auditing reports or (2) sensitive contractual and competitive information the release of which would cause harm to the utility or the provider of the information.

To qualify for confidential classification, the information must be held as confidential and not publicly disclosed. FPL witnesses Del Cueto and Bromley report the material has been held as confidential by FPL.

### **Confidential Classification Period**

Section 366.093(4), Florida Statutes, limits the length of confidential protection to 18 months unless, for good cause shown, a longer protection period is appropriate. In this case, we recommend the confidential time period be limited to 18 months.

FPL has requested that the material be held as confidential for at least 18 months. The utility has also requested that this material be returned to FPL when the Commission no longer needs the information in accordance with the provisions of Section 366.093(4), F.S.

The Commission has recently responded to a utility's request for return of audit information classified as confidential in Commission Order PSC-98-1024-CFO-EG, dated July 28, 1998. The Prehearing Officer's order provided that since Commission audit working papers are retained by the Commission for a period of 25 years, this material which is confidential also needs to be retained by the Commission for that period. The Order went on to state; "if prior to the expiration of the [18 month] confidential time period, FPL wishes to petition for continued confidential classification of this material, it may do so for good cause".

A detailed recommendation, as found, follows identifying each document recommended for a confidential classification.

On May 17, 1999, staff made a recommendation regarding FPL's request for a confidential classification in this matter. That recommendation is superseded as provided herein in response to FPL's July 12, 1999, revision to its request.

On March 8, 1999 and March 11, 1999, when copies of certain portions of staff's audit report and working papers regarding "Bidding Naples Rock Conditions" were delivered to the FPL at the audit exit conference, the utility requested that these documents be temporarily excepted from public access in accordance with the provisions of Rule 25-22.006(3)(a)(2), Florida Administrative Code (FAC). On March 17, 1999, staff filed documents 03218-99, 03219-99, 03220-99, 03221-99, and 03222-99 consisting of those specified portions of the audit report and working papers. These documents are currently held by the Division of Records and Reporting and designated as temporarily exempt from public access.

On March 17, 1999, the utility filed a request pursuant to Rule 25-22.006, FAC, and Section 366.093, Florida Statutes (F.S.), that selected portions of the staff audit report and working papers prepared by staff during the audit receive confidential classification. The utility's request included highlighted copies (03455-99) and redacted copies (Exhibit B, Document 03454-99) for public use. On July 17, 1999, after discussions with the staff, FPL revised its request correcting an error in its listing of confidential documents reported in its initial filing.

Pursuant to Section 119.07, F. S., documents submitted to this Commission are public records. The only exemptions to this law are specific statutory exemptions and exemptions granted by governmental agencies pursuant to the specific terms of a statutory provision. Subsections 366.093(3)(b)(d) and (e), F.S., provide the following exceptions:

“Proprietary confidential business information means information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the person’s or company’s business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public. Proprietary confidential business information includes, but is not limited to:....

- (b) Internal auditing controls and reports of internal auditors....
- (d) Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms.
- (e) Information related to competitive interests, the disclosure of which would impair the competitive business of the provider of the information....”

According to Section 366.093, F. S., and Rule 25-22.006, FAC, the utility has the burden of demonstrating that materials qualify for confidential classification. According to Rule 25-22.006, FAC, the utility must meet this burden by demonstrating that the information is proprietary confidential business information, the disclosure of which will cause the utility, the provider of the information or the ratepayer harm.

### **Staff Analysis of FPL’s Request**

Analysis of the utility’s request and listing of confidential materials reveals the sensitive information presented in the filing consists of:

#### **1) Internal Audit Reports**

FPL witness Del Cueto, FPL Manager, Internal Auditing, attests that the materials in this filing contain or constitute “....internal auditing controls and reports of internal auditors or information relating to same....”

#### **2) Contractor competitive bid submittals**

#### **3) FPL summaries of contractor bids**

#### **4) Purchase order numbers**

- 5) Other contractual data such as pricing and other terms, payment records and contractor rates.

According to the utility, "Disclosure of this information would impair the efforts of FPL to contract for joint trenching services on favorable terms and/or impair the competitive interests of the contractors." For example, witness Bromley, FPL Manager, Regulatory Strategy, Distribution Business Unit, indicates in his deposition, Document 03456-99, Exhibit D; "...the disclosure of project-specific purchase order numbers might enable a contractor's competitor to improperly obtain from FPL contractual data relative to specific contracts or other contractors."

### **Staff Recommendation**

Based upon review of the sensitive materials presented in this filing, we recommend the materials be granted a confidential classification on the basis that the materials disclose (1) either internal auditing controls or internal auditing reports or (2) sensitive contractual and competitive information the release of which would cause harm to the utility or the provider of the information.

To qualify for confidential classification, the information must be held as confidential and not publicly disclosed. FPL witnesses Del Cueto and Bromley report the material has been held as confidential by FPL.

### **Confidential Classification Period**

Section 366.093(4), Florida Statutes, limits the length of confidential protection to 18 months unless, for good cause shown, a longer protection period is appropriate. In this case, we recommend the confidential time period be limited to 18 months.

FPL has requested that the material be held as confidential for at least 18 months. The utility has also requested that this material be returned to FPL when the Commission no longer needs the information in accordance with the provisions of Section 366.093(4), F.S.

The Commission has recently responded to a utility's request for return of audit information classified as confidential in Commission Order PSC-98-1024-CFO-EG, dated July 28, 1998. The Prehearing Officer's order provided that since Commission audit working papers are retained by the Commission for a period of 25 years, this material which is confidential also needs to be retained by the Commission for that period. The Order went on to state; "if prior to the expiration of the [18 month] confidential time period, FPL wishes to petition for continued confidential classification of this material, it may do so for good cause".

A detailed recommendation, as found, follows identifying each document recommended for a confidential classification.
