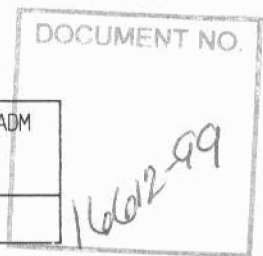



Dear Residents of Bayside Mobile Home Park,

I am writing to you in particular because of an ongoing problem and I want to make sure that each of you has a clear understanding of the law and our position concerning this matter. In the past, I have personally witnessed some of you placing, on County right of way or on our property, yard trimmings, grass cuttings, etc. as listed above. I recently drove up on Mr. Ralph Donaldson dumping palm fronds and a bag of clippings across the road from his house, partially on our property and on County right of way. I have on numerous occasions, seen Mr. and Mrs. Merck taking similar clippings and cuttings and throwing them across the road from their house onto the County right of way and on our property in the bushes. When I approached Mr. Donaldson and caught him red-handed, he argued with me about having the right to do that and even claimed that the County would pick it up.

Let me be perfectly clear with all of you. For years I have allowed my men, at Bayside's expense, as they made their rounds for our customers who paid us for trash service, to continue on down in front of your houses and pick up the mess you have thrown alongside the road. That will no longer occur, ever again. Also, in talking with those who handle the solid waste department, not only is it against the law for you to dump it on our property, but it is against the law to dump it on the County right of way. The only exception is that if you have a paid service that comes by at a scheduled time and you place trash and garbage alongside the road in proper containers in front of your homes, not across the road, for them to pick up. From this point on, whenever there is an infraction of dumping on our property or on the County right of way, we will simply call an enforcement officer to contact you about the matter. Thank you.
