

ORDER OF RELIEF AND ORDER TO

OF AFFAIRS

On the consideration of the petition filed on June 11, 1999 against the above-named debtor(s), an Order of Relief under Chapter 11 of title 11 of the United States code is GRANTED.

IT IS FURTHER ORDERED that the above-named debtor(s) or the petitioning creditor(s) or trustee, pursuant to Federal Rule of Bankruptcy Procedure 1007(k) shall prepare, make oath to, and file in this Court, within fifteen (15) days from the date hereof, a *schedule of his property, showing the amount and kind of property, the location thereof and its money value in detail; and a list of all of its creditors showing their residences or place of business if known, or if unknown that fact to be stated, the amount due to or claimed by each of them, the consideration thereof, the date each debt was incurred and the security held by them, if any; also a *statement of its affairs.

IT IS FURTHER ORDERED that any relief from automatic stay motion previously granted by the Court in this case shall remain in force and effect notwithstanding this order of relief.
