



BEFORE ME, the undersigned authority, personally appeared MATTHEW P. HARRIS, who being first duly sworn, deposes and says:

1. My name is Matthew P. Harris and I am a Senior Consulting Project Manager for Henwood Energy Services, Inc. ("HESI"). I have held various positions with HESI since 1997 and am authorized to submit this affidavit on behalf of HESI.


2. This affidavit is based on my personal knowledge or belief. If called as a witness, I could truthfully testify as to the matters contained in this affidavit.

3. HESI produces and licenses electric market simulation models and provides consulting services to the electric industry. HESI's models are typically licensed to its customers on an annual basis. However, HESI also offers short-term, project specific licenses to customers that do not require an annual unlimited-use license.

4. As an example, HESI produces a model and database of the electric power market in the eastern United States, entitled the Eastern Interconnect Model. This model is licensed to customers of HESI on an annual, unlimited-use basis for approximately \$80,000 to \$120,000.


To accommodate customers that need access to the Eastern Interconnect Model for only a limited time and purpose, HESI also allows the model to be licensed for specific projects or studies. These licenses will typically be limited to a specific purpose and issued for three-month period. Pursuant to such a license the model will be installed on between two and five of the licensee's computers. The licensee is allowed unlimited access to the model on those computers during the license period for the project in question. At the end of the license period, HESI will remove the model from the licensee's computers. The cost of a three-month, single-project license to the Eastern Interconnect Model typically does not exceed \$25,000
