* With regards to Document No. 00746-94, which was signed out by Jena Price in 1994 before she left the Commission, staff has checked the docket file in our central file room in this division and the file cabinet where the tax returns were kept, but unfortunately, we have not been able to locate that document. We have a locked file cabinet to store Confidential tax returns in when they are not in use by staff; therefore, staff is at a loss as to where that particular document could be. Based on the list that you provided to Connie McCaskill, it appears that Document 00746-94 and 02040-94 both contained tax returns for 1993. Is it possible that the tax return for Document 00746-94 got mixed up with Document 02040-94?

In addition, for informational purposes, our records indicate that Order No. PSC-94-0274-FOF-WS, was issued on March 9, 1994, cancelling the tariffs and approving the sale of Sunbelt Utilities, Inc. to Village Center Community Development District, effective November 29, 1993. We do not regulate Village Center Community Development District.

Finally, Document No. 02040-94 which was checked out by Christine Romig, has been added to this list to be returned to the utility. Christine advised us that she was returning the tax returns to Records and Reporting.
