

SUMTER ELECTRIC COOPERATIVE, INC.'S REPORT  
ON STATUS OF TERRITORIAL AGREEMENT BETWEEN  
FLORIDA POWER CORPORATION AND SUMTER ELECTRIC COOPERATIVE, INC.

In Order No. PSC-97-0611-FOF-EU, issued on May 28, 1997 in Docket No. 961533-EU the Commission approved the territorial agreement entered into by and between Florida Power Corporation and Sumter Electric Cooperative, Inc. The Order calls for an annual report from Sumter Electric Cooperative, Inc. providing the status of the Agreement and any modifications proposed in the Agreement.


This is to advise the Commission that the subject territorial agreement remains in full force and effect and that no modifications have been proposed in such agreement nor have the parties encountered any disputes concerning the provisions of such agreement.

Pursuant to Section 2.2 of the Territorial Agreement, Sumter Electric Cooperative, Inc. transferred seventeen (17) consumers from Sumter Electric Cooperative, Inc. to Florida Power Corporation on February 16, 1999. In addition, Sumter Electric Cooperative, Inc. continues to serve an area light on an interim basis.

The parties will advise the Commission to the extent that any changes are proposed to the existing Territorial Agreement and will petition the Commission to resolve any disputes which may arise concerning the provisions of the Agreement which the parties are unable to resolve.
