SouthNet TeleComm Services, Inc. ("SouthNet") is in receipt of a Case Assignment and Scheduling Record in the above-referenced docket, setting for hearing before the Commission the matter of cancellation of SouthNet's ALEC Certificate No. 5710 as a result of the Company's failure to submit its Regulatory Assessment Fees: Telecommunications Companies Return for calendar year 1998. SouthNet had no intrastate revenues from local telecommunications services within the State of Florida during calendar year 1998, and a review of the Company's records indicates that as a result, the ALEC Regulatory Assessment Fees Return was inadvertently omitted. That Return, accompanied by a check for the minimum assessment amount plus interest and penalties, is enclosed herewith.

SouthNet regrets this omission and has established internal procedures designed to prevent any inadvertent omission to file required regulatory returns in the future. Accordingly, the Company respectfully requests that the Commission forego cancellation of ALEC Certificate No. 5710 and


