Within Rule 25-6.135, Florida Administrative Code, Annual Reports, Rule 25-6.1351, Florida Administrative Code, Diversification Reports, and Rule 25-6.0436, Florida Administrative Code, Depreciation.

5. a. What is the specific legal authority for the rule, i.e., what statute says you can adopt rules?

6. Summary of rules:

We are proposing that Rule 25-6.1351 be revised to insure that the rates paid by ratepayers do not subsidize non-regulated operations. The Florida Public Service Commission presently does not have any accounting rules for the electric utilities in place which address this issue. This rule currently requires the regulated investor-owned electric utilities to file yearly schedules with AFAD as an attachment to its annual report using Schedule PSC/AFA 16. This schedule is an existing schedule. We are proposing that one additional

schedule be developed, with the new schedule and the existing schedules being made a part of the annual report.

Revising this rule will help insure that all the regulated investor-owned electric utilities properly account for transactions with affiliates in a uniform manner. The rule revisions spell out cost allocation accounting principles and audit requirements the utilities are expected to follow, and lists guidelines the utilities must use when recording accounting transactions between the regulated utility and affiliates. It begins with a "Purpose" section, and then a "Definition" section. "Non-tariffed Affiliate Transactions" requirements are listed, followed by "Cost Allocation Principles", "Reporting Requirements" and "Cost Allocation Manual".

We are proposing that Rule 25-6.135 be amended to update the annual report Form PSC/AFA 19 and to include in the electric annual report the schedules that are a part of PSC/AFA 16.

We are proposing that Rule 25-6.0436 be amended to include depreciation related definitions. These definitions, as used in this rule, effect the value of transactions between affiliated companies. In addition, we are proposing that additional language relating to the treatment of depreciation reserve accounts associated with transfers of property between affiliates be included.

7. Are any forms or other material such as statutes or rules referenced in the rules?

Yes; Form PSC/AFA 16 and Form PSC/AFA 19.

8. Purpose and effect of the rule adoption/amendment/repeal:

To insure proper accounting between regulated investor-owned electric utilities and their affiliates to prevent subsidization of nonregulated activities by utility ratepayers.

9. Facts and circumstances justifying rule:

The regulated investor-owned electric utilities are entering more non-regulated businesses. It is necessary to have guidelines in place to help prevent inappropriate accounting practices for transactions and subsidization of nonregulated activities by utility ratepayers.

10. Will these rules affect small businesses as defined in Section 288.703(1)?

11. Identify the benefits that should result from the rule adoption/amendment/repeal to:

a. utilities: Certainty as to Commission's accounting requirements for non-regulated allocations and transactions with affiliates.

b. ratepayers: The assurance that regulated investor-owned electric utilities' rates are not increased to subsidize non-regulated affiliates.

c. Commission staff: Auditing should be easier because the guidelines will insure a degree of uniformity between the regulated investor-owned electric utilities.

d. small business: None.

It is possible that all ratepayers will incur higher charges if these rules are not revised. The benefits include a greater assurance that all regulated investor-owned electric

utilities have guidelines protecting against subsidization of nonregulated activities by utility ratepayers.

3 (1) Purpose. The purpose of this rule is to establish cost
4 allocation requirements to ensure proper accounting for affiliate
5 transactions and utility nonregulated activities so that these
6 transactions and activities are not subsidized by utility
7 ratepayers. This rule is not applicable to affiliate transactions
8 for purchase of fuel and related transportation services that are
9 subject to Commission review and approval in cost recovery
10 proceedings.

11 ~~(1) Each investor owned electric utility shall file~~
12 ~~information on its affiliates and affiliated transactions on~~
13 ~~Commission Form PSC/AFA 16 (12/94) which is incorporated into this~~
14 ~~rule by reference. Form PSC/AFA 16, entitled "Analysis of~~
15 ~~Diversification Activities", may be obtained from the Commission's~~
16 ~~Division of Auditing and Financial Analysis.~~

17 (2) Definitions

18 (a) Affiliate -- Any entity that directly or indirectly
19 through one or more intermediaries, controls, is controlled by, or
20 is under common control with a the utility. As used herein,
21 "control" means the possession, directly or indirectly, of the
22 power to direct or cause the direction of the management and
23 policies of a company, whether such power is exercised through one
24 or more intermediary companies, or alone, or in conjunction with,
25 or pursuant to an agreement, and whether such power is established

1 through a majority or minority ownership or voting of securities,
2 common directors, officers or stockholders, voting trusts, holding
3 trusts, associated companies, contracts or any other direct or

5 ~~securities of an entity shall be conclusively deemed to constitute~~
6 ~~the control thereof.~~

7 (b) Affiliated Transaction -- Any transaction in which both a
8 utility and an affiliate thereof are each participants, except
9 ~~other than~~ transactions related solely to the filing of
10 consolidated tax returns.

11 (c) Cost Allocation Manual (CAM) - The manual that sets out
12 a utility's cost allocation policies and related procedures.

13 (d) Direct Costs - Costs that can be specifically identified
14 with a particular service or product.

15 (e) Fully Allocated Costs - The sum of direct costs plus a
16 fair and reasonable share of indirect costs.

17 (f) Indirect Costs - Costs, including all overheads, that
18 cannot be identified with a particular service or product.

19 (g) Nonregulated - Refers to services or products that are
20 not subject to price regulation by the Commission or not included
21 for ratemaking purposes and not reported in surveillance.

22 (h) Prevailing Price Valuation - Refers to the price an
23 affiliate may charge a regulated utility for products and services,
24 which equates to that charged by the affiliate to third parties.

25 To qualify for this treatment, sales of a particular asset or

1 service to third parties must encompass more than 50 percent of the
2 total quantity of the product or service sold by the entity. The
3 50 percent threshold is applied on an asset-by-asset and service-
4 by-service basis, rather than on a product line or service line
5 basis.

6 (i) Regulated - Refers to services or products that are
7 subject to price regulation by the Commission or included for
8 ratemaking purposes and reported in surveillance.

9 (j) Subsidize - The act of regulated utility operations
10 paying more than their fair and reasonable share of costs
11 associated with affiliate transactions and utility nonregulated
12 activities.

13 (3) Non-Tariffed Affiliate Transactions

14 (a) The purpose of subsection (3) is to establish
15 requirements for non-tariffed affiliate transactions impacting
16 regulated activities.

17 (b) A utility must charge an affiliate the higher of fully
18 allocated costs or market for all non-tariffed services and
19 products purchased by the affiliate from the utility. Except, a
20 utility may charge an affiliate less than fully allocated costs if
21 the charge is above incremental cost and equivalent to market
22 prices. If a utility charges less than fully allocated costs, the
23 utility must maintain documentation to support and justify doing so
24 would benefit regulated operations.

25 (c) When a utility purchases services and products from an

1 affiliate and applies the cost to regulated operations, the utility
2 shall apportion to regulated operations the lesser of fully
3 allocated costs or market price. Except, a utility may apportion
4 to regulated operations more than fully allocated costs if the
5 charge is less than or equal to the market price. If a utility
6 apportions to regulated operations more than fully allocated costs,
7 the utility must maintain documentation to support and justify
8 doing so would benefit regulated operations and would be based on
9 prevailing price valuation.

10 (d) When an asset used in regulated operations is transferred
11 from a utility to a nonregulated affiliate, the utility must charge
12 the affiliate the greater of market or net book value. When an
13 asset to be used in regulated operations is transferred from a
14 nonregulated affiliate to a utility, the utility must record the
15 asset at the lower of market or net book value. An independent
16 appraiser must verify the market value of a transferred asset with
17 a net book value greater than \$1,000,000.

18 (e) Each affiliate involved in affiliate transactions must
19 maintain all underlying data concerning the affiliate transaction
20 for at least three years after the affiliate transaction is
21 complete. This paragraph does not relieve a regulated affiliate
22 from maintaining records under otherwise applicable record
23 retention requirements.

24 (4) Cost Allocation Principles

25 (a) Utility accounting records must show whether each

1 transaction involves a product or service that is regulated or
2 nonregulated.

3 (b) Direct costs shall be assigned to each non-tariffed
4 service and product provided by the utility.

5 (c) Indirect costs shall be distributed to each non-tariffed
6 service and product provided by the utility on a fully allocated
7 cost basis. Except, a utility may distribute indirect costs on an
8 incremental or market basis if the utility can demonstrate that its
9 ratepayers will benefit. If a utility distributes indirect costs
10 on less than a fully allocated basis, the utility must maintain
11 documentation to support doing so.

12 (d) Each utility must maintain a listing of revenues and
13 expenses for all non-tariffed products and services.

14 (5) Reporting Requirements. Each utility shall file
15 information concerning its affiliates, affiliate transactions, and
16 nonregulated activities on Form PSC/AFA 19 (xx/xx) which is
17 incorporated by reference into this rule. Form PSC/AFA 19,
18 entitled "Annual Report of Major Electric Utilities," may be
19 obtained from the Commission's Division of Auditing and Financial
20 Analysis.

21 (6) Cost Allocation Manual. Each utility involved in
22 affiliate transactions or in nonregulated activities must maintain
23 a Cost Allocation Manual (CAM). The CAM must be organized and
24 indexed so that the information contained therein can be easily
25 accessed.

22 may be obtained from the Commission's Division of Auditing and

25 shall be due on or before April 30 for the preceding calendar year.

13 a category as evidenced by a comparison of that reserve indicated
14 as necessary under current projections of life and salvage with

(11) 'project' means a complete unit of improvement or development, consisting of a power house, all water conduits, all dams and appurtenant works and structures (including navigation structures) which are a part of said unit, and all storage, diverting, or forebay reservoirs directly connected therewith, the primary line or lines transmitting power therefrom to the point of junction with the distribution system or with the interconnected primary transmission system, all miscellaneous structures used and useful in connection with said unit or any part thereof, and all water rights, rights-of-way, ditches, dams, reservoirs, lands, or interest in lands the use and occupancy of which are necessary or appropriate in the maintenance and operation of such unit;

"Sec. 4. The Commission is hereby authorized and empowered -

(a) To make investigations and to collect and record data concerning the utilization of the water resources of any region to be developed, the water-power industry and its relation to other industries and to interstate or foreign commerce, and concerning the location, capacity, development costs, and relation to markets of power sites,...to the extent the Commission may deem necessary or useful for the purposes of this Act."

"Sec. 304. Such reports shall be made under oath unless the Commission otherwise specifies."
