**BELLSOUTH TELECOMMUNICATIONS, INC.'S
AMENDMENT TO DISCOVERY RESPONSES**

BellSouth Telecommunications, Inc. ("BellSouth"), hereby files its Amendment to Discovery previously propounded by BlueStar Networks, Inc. ("BlueStar"), and states the following:

1. On January 18, 2000, BellSouth objected to BlueStar's Request to Produce No. 8 because, although the request did not call for information regarding retail offerings on its face, it appeared to be so broad as to encompass this information. BellSouth has since determined that the only responsive documents that it has in its possession, custody or control relate to unbundled network elements, i.e., wholesale rather than retail services. Accordingly, BellSouth withdraws its objection and agrees to produce the responsive information at a mutually agreeable time and place. BellSouth also notes, however, that this information is proprietary, that it will be produced only upon the execution of an appropriate protective order, and that it may be viewed only by the persons who are covered by the protective agreement.

2. In BellSouth's response to BlueStar's Interrogatory No. 1, BellSouth identified particular engineering guidelines and stated that this information is proprietary. BellSouth has determined that, although the contents of the guidelines are proprietary, the fact that BellSouth utilizes these guidelines is not. Therefore, BellSouth withdraws the proprietary classification for its response to BlueStar's Interrogatory No. 1.
