Dear Ms. Bayo:

On behalf of Network International, LC d/b/a Network International of the South, LC ("Network International"), a certificated reseller of long distance telecommunications services in Florida, we respectfully submit the attached copy of its Regulatory Assessment Fee Return ("RAFR") for 1998, along with a copy of the check in the amount of \$68.00.

Network International was informed of its failure to file its 1998 RAFR, in violation of Rule 25-4.0161, by the Florida Public Service Commission via facsimile dated December 22, 1999. Upon learning of this violation, Network International undertook prompt corrective action and submitted its 1998 form and paid the \$50.00 minimum, \$12.50 penalty, and \$5.50 interest.

Network International obtained its certificate of authority to operate as a reseller of long distance services in Florida on November 10, 1998. Due to the fact that it obtained its certificate a scant month and a half prior to the end of fiscal 1998 and was not fully operational in Florida until the following year, Network International was unaware of the requirement to file a RAFR. Now that it has been made aware that certificated telecommunications carriers, whether or not operational, must file the RAFR, Network International will, as evidenced by the early filing of its 1999 RAFR,


