This will acknowledge receipt of your recent request for cancellation of your pay telephone certificate. I cannot recommend voluntary cancellation of a company's certificate when there is an outstanding balance of the regulatory assessment fee and/or statutory penalty and interest charges.

According to the Commission's records, you have a past due balance of \$12.00. Our records show that you paid the 1992 fee on April 8, 1993, which was due January 30, 1993. However, you did not pay the \$7.50 penalty or \$1.50 interest, leaving a balance of \$9.00 for 1992. You paid the 1993 fee on February 18, 1994, which was due January 30, 1994. However, you did not pay the \$2.50 penalty and \$.50 interest leaving a balance of \$3.00 for 1993.

As soon as your check is received for the \$12.00, I will open a docket to cancel your certificate with an effective date of December 31, 1999. Please let me hear from you by February 8, 2000.




Upon consideration of the record in the above numbered docket, it is
