Dear Mr. Slipenchuk:

On December 20, 1999, Order No. PSC-99-2480-PAA-TI was issued, which imposed a \$500 fine for nonpayment of the 1998 regulatory assessment fee and penalty and interest from the 1996 fee, or canceled Fiberlink's certificate. The company had until January 10, 2000 to respond to the Order. On December 27, you called me and left a voice mail message advising that you had talked with Ms. Jackie Knight of our Division of Administration back in September and had already paid the past due amount. I called you back later that day and explained that our records did not show receipt of the past due amount and asked for a copy (front and back) of the canceled check. You told me that your secretary was out that day, but that when she returns the next day, you would have her fax me a copy of the canceled check. In addition, you said you would fax me a copy of the return today. I did not receive a copy of the return nor did your secretary call me on December 28.

On January 10, 2000, Tina Parekh called me and said she would research her records and call me back. She called back on January 12 and said that although you had given her the file and told her to send a check, it had never been done. She said she would send one out on Friday. I later called Ms. Parekh on the same day (1/10) and explained that in addition to paying the past due amount, the company needed to make a settlement offer. She asked me to fax her information on how to make a settlement offer. I faxed the 1998 return form and requested information on January 13. Later on January 13, the consummating order was issued which stated since a response had not been filed to the Order issued on December 20, Order No. PSC-99-2480-PAA-TI became effective and final.

Just recently, on January 31, 2000, the Commission received a check from Fiberlink for \$100 without a letter of explanation. Since your certificate was canceled with an effective date of January 13, 2000, you would need to pay the past due regulatory assessment fee (1998 and 1999), including statutory penalty and interest, in full, pay the \$500 fine, and apply for a new certificate, which
