



**BELLSOUTH TELECOMMUNICATIONS, INC.'S NOTICE OF INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION**

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification.

1. On January 5, 2000, BlueStar Networks, Inc. ("BlueStar") served its First Set of Interrogatories and First Request for Production of Documents to BellSouth. On January 18, 2000, BellSouth filed its General and Specific Objections to that discovery and on January 25, 2000, BellSouth served its Responses and Objections to that discovery.

2. The information contained in BellSouth's response to Request for Production Nos. 2, 3, 8, 10, 11, 13, 14 and 18 includes strategic planning and cost information that could cause competitive harm to BellSouth and is clearly confidential and proprietary under Florida Statutes, Section 364.183.


3. BellSouth's responses to this discovery produced approximately 5,065 pages. Upon BlueStar's review of the responsive documents they requested copies of approximately 217 pages. Staff has requested a copy of the same documents. Some of the information contained in these documents is proprietary and includes strategic planning and cost information.
