


**BELLSOUTH TELECOMMUNICATIONS, INC.'S
PROPOSED ISSUES LIST**

1. Under the Telecommunications Act of 1996, can Atlantic require BellSouth to include a provision in the Resale Agreement whereby BellSouth is precluded from offering service to consumers covered by an exclusive service arrangement with Atlantic?
2. In the event of a unauthorized change in local service (*i.e.*, slamming) by Atlantic, is BellSouth allowed to recover from Atlantic the costs BellSouth incurs in returning the slammed customer to the appropriate local service provider? If so, should the obligation be reciprocal?
