Order No. PSC-99-2498-PAA-TC was issued on December 20, 1999. The company had until January 10, 2000 to protest. On January 14, the Consummating Order was issued, which canceled the company's certificate effective that date.

On January 5, your office notified me by memo that this company had paid its 1999 regulatory assessment fee and provided updated information. The memo was inadvertently filed without action being taken by staff to contact the company.

Since the company responded to the Order timely, this docket needs to be reopened. I am in the process of writing the company and revising the CASR since this needs to go back to Agenda. In addition, Legal advised me that an order will be issued vacating the Consummating Order. Let me know if you have any questions.
