

JOINT MOTION FOR WITHDRAWAL OF PETITION
FOR SECTION 252(b) ARBITRATION

BellSouth Telecommunications, Inc. ("BellSouth") and Time Warner Telecom of Florida, L.P. ("Time Warner") jointly move to withdraw BellSouth's Petition for Arbitration filed October 15, 1999 pursuant to Section 252(b) of the Telecommunications Act of 1996 seeking resolution of certain issues arising between Time Warner and BellSouth in the negotiation of an Interconnection Agreement. The parties have resolved the single issue set forth in the Petition for Arbitration and are in the process of executing a new Interconnection Agreement that will be submitted to the Florida Public Service Commission for approval. Accordingly, BellSouth and Time Warner jointly move to withdraw the Petition for Arbitration and request that this motion be acted upon after the parties' new interconnection agreement has been submitted for Commission approval.
