This letter serves to advise the Commission that the interconnection of Fisherman's Cove of Stuart, Inc.'s internal distribution and collection lines to Martin County's water and wastewater mains occurred on February 17, 2000, making that the effective date of the transfer.

The date the closing documents will be signed is anticipated to be March 15th. However, there will be no transfer of deeds as Martin County is not acquiring the utility's water and wastewater plants. Pursuant to contract, the plants are to be retained by the seller for decommissioning as soon as practicable after closing.
