Time Warner is a facilities-based carrier presently providing exchange access and local exchange telecommunications services in Florida. Accordingly, Time Warner is subject to the rules, regulations, and orders of the Commission, and such rules, regulations, and orders impact Time Warner in the provision of telecommunications services, and Time Warner's ability to compete.

4. As an ALEC, Time Warner must utilize the operations support systems of incumbent local exchange companies in order to provide local exchange service in Florida. Thus, Time Warner's interests may or will be substantially and directly affected by any decision regarding permanent performance measures for incumbant local exchange companies.

For the reasons stated above, Time Warner respectfully requests that the Commission grant its Petition for Leave to Intervene and accord Time Warner full party status in this proceeding.
