
1. COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), pursuant to Rule 25-22.006, Florida Administrative Code, and files its Notice of Intent to Request Specified Confidential Classification. BellSouth is filing on this date its Rebuttal Testimony of Alphonso J. Varner. The information in Rebuttal Exhibit AJV-2 is confidential and proprietary under Florida Statutes, Section 364.183 and Rules 25-22.006, Florida Administrative Code. Specifically, said Exhibit contains customer proprietary information concerning the accounts of Intermedia, the production of which could subject BellSouth to penalties under Section 364.24, Florida Statutes.
