


Re: Docket Number 991453-TI: Transamerica Communications, Inc.

Dear Paula and Kimberly:

As I discussed with each of you, Transamerica Communications, Inc. (Transamerica) filed a petition on proposed agency action in the above docket to provide it an opportunity to investigate whether Certificate No. 2941 should remain in effect in light of the acquisition of Transamerica, Inc. by Transamerica and the subsequent reorganization of the business. We have determined that no traffic is being carried or billed pursuant to the certificate, meaning that all customers formerly served by Transamerica have either been moved to a different billing platform of an affiliate or have changed carriers. Accordingly, we withdraw the request for hearing and ask that Certificate No. 2941 be canceled. In view of the voluntary surrender of the certificate, it is our understanding that no fines will be assessed.

Since I spoke with you, Transamerica has paid the sum of \$68.50 for past regulatory assessment fees and interest. Transamerica acknowledges its obligation to pay fees applicable to the Year 2000, and will remit that amount prior to March 31, 2000.
