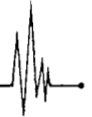

Dear Ms. Bayo:

The following is in response to the Docket No. 991832-TI regarding the cancellation of Preferred Voice, Inc.'s ("Preferred") IXC Certificate No. 5697 for violation of Rule 25-4.0161.

In February 1997, Preferred sold a number of our assets, including the company's end-user customer base and ceased operations as an interexchange carrier. Preferred immediately began operating as an enhanced telecommunications services provider and offers only voice recognition services. Since Preferred no longer offers long-distance services, we request a voluntary cancellation of our Certificate No. 5697 to operate as an IXC in Florida. Attached are the Regulatory Assessment Fee Returns for 1998 and 1999 along with a check in the amount of \$125.50 for the fees due plus penalties and interest calculated thru March 31, 2000.

I believe this satisfies the requirements of Docket No. 991832-TI; therefore, I believe no further action should be necessary on our part.
