Dear Ms. Bayó:

On March 9, 2000, BellSouth Telecommunications, Inc. filed with the Florida Public Service Commission the final Interconnection Agreement between itself and ICG Telecom Group, Inc. In that Agreement there were two provisions that remained in dispute, section 1.9 of Attachment 2, regarding BellSouth's provision of an Enhanced Extended Link ("EEL") to ICG and section 6.1.1 of Attachment 3, regarding compensation for ISP bound traffic. On March 9, 2000, both Parties submitted to the Commission its proposed language for the disputed provisions with justification for its proposal.

BellSouth and ICG are pleased to report to the Commission and its Staff that the parties have reached agreement on language for both of the provisions that were at issue. Therefore, the Commission need not have to address the pleadings of the parties filed on March 9, 2000. BellSouth and ICG are in the process of finalizing the agreement and securing signatures. BellSouth and ICG will submit for the Commission's approval, a final executed agreement as soon as possible.

Both Parties wish to thank the Commission and its Staff for their efforts in the above styled case.




