COMES NOW, Intermedia Communications Inc. ("Intermedia"), pursuant to Rule 25-22.006, Florida Administrative Code, and files its Motion for Extension of Duration of Order Granting Confidential Classification, and states as grounds in support thereof the following:

1. On July 17, 1998, Intermedia filed a Request for Confidential Classification of information contained in its response to Commission Staff's April 13, 1998, data request. This information contains proprietary business information.
2. By Order No. PSC-98-1195-CFO-TL, issued September 8, 1998, the Commission granted Intermedia's Request for Confidential Classification.
3. The information requested remains in the possession of Staff subject to confidential treatment.
4. The reasons Intermedia asserted in support of confidential treatment in its original motions continue to pertain. Specifically, there is still a need to protect the information as proprietary business information from public disclosure.


