Attached is a copy of Rule 25-24.820(2)(a), (b), (c), and (d), Florida Administrative Code, which outlines how a company may request voluntary cancellation of their certificate. Write a letter to the Commission and provide the information as outlined in the above rule and request voluntary cancellation of your Certificate No. 5253. Unfortunately, I cannot recommend voluntary cancellation of a company's certificate when there is an outstanding balance for the regulatory assessment fee.

In this case, our records show that the 1997 fee was paid on February 23, 1998 (payment was due January 30, 1998). However, the \$3.00 statutory penalty and interest charges were not paid. In addition, the 1999 fee has not been paid yet. If it is postmarked by March 30, the total due for 1999 is \$56.00. Also, the 2000 fee must be paid.


