

PURPOSE AND EFFECT: To adopt a rule specifying the time period to be used in the equation for calculating the used and useful percentage of wastewater treatment plant.

SUBJECT AREA TO BE ADDRESSED: Flow data for calculating the used and useful percentage for wastewater treatment plant.

THE PRELIMINARY TEXT OF THE PROPOSED RULE IS:

25-30.432 Flows to be Used for Wastewater Treatment Plant Used and Useful Calculations. The used and useful percentage of a wastewater treatment plant shall be calculated using a ratio of actual flows, plus the amount calculated pursuant to Rule 25-30.431 and minus excess infiltration and inflow, to the permitted plant capacity. The denominator shall be the plant capacity as stated on the permit issued by the Department of Environmental Protection for the utility's treatment plant. The flows in the numerator shall be the flow data stated in the same unit of measurement as the denominator.
