

The above two dockets relate to amendments to the interconnection agreement between BellSouth Telecommunications, Inc. (BellSouth) and BlueStar Networks, Inc. (BlueStar). Currently, the amendment in Docket No. 000174-TP is scheduled to be considered at the April 4th Agenda Conference. The amendments in Docket No. 000357-TP were filed on March 24th and have not yet been scheduled for consideration by the Commission.


