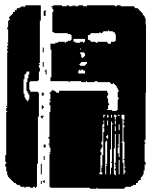

Enclosed is a copy of Public Service Commission Order Number PSC-00-0582-PRF-SU, which memorialized the action the Commission took at its February 29, 2000 agenda approving the Little Sumter Utility Company tariff for reclaimed water service. The PFC approved a zero rate for the distribution of reclaimed water from Little Sumter Utility Company to The Villages of Lake-Sumter, Inc..

Although a zero rate for reclaimed water was established, the PSC's decision in this case does not preclude the PFC from establishing a reuse rate higher than zero in the future.
