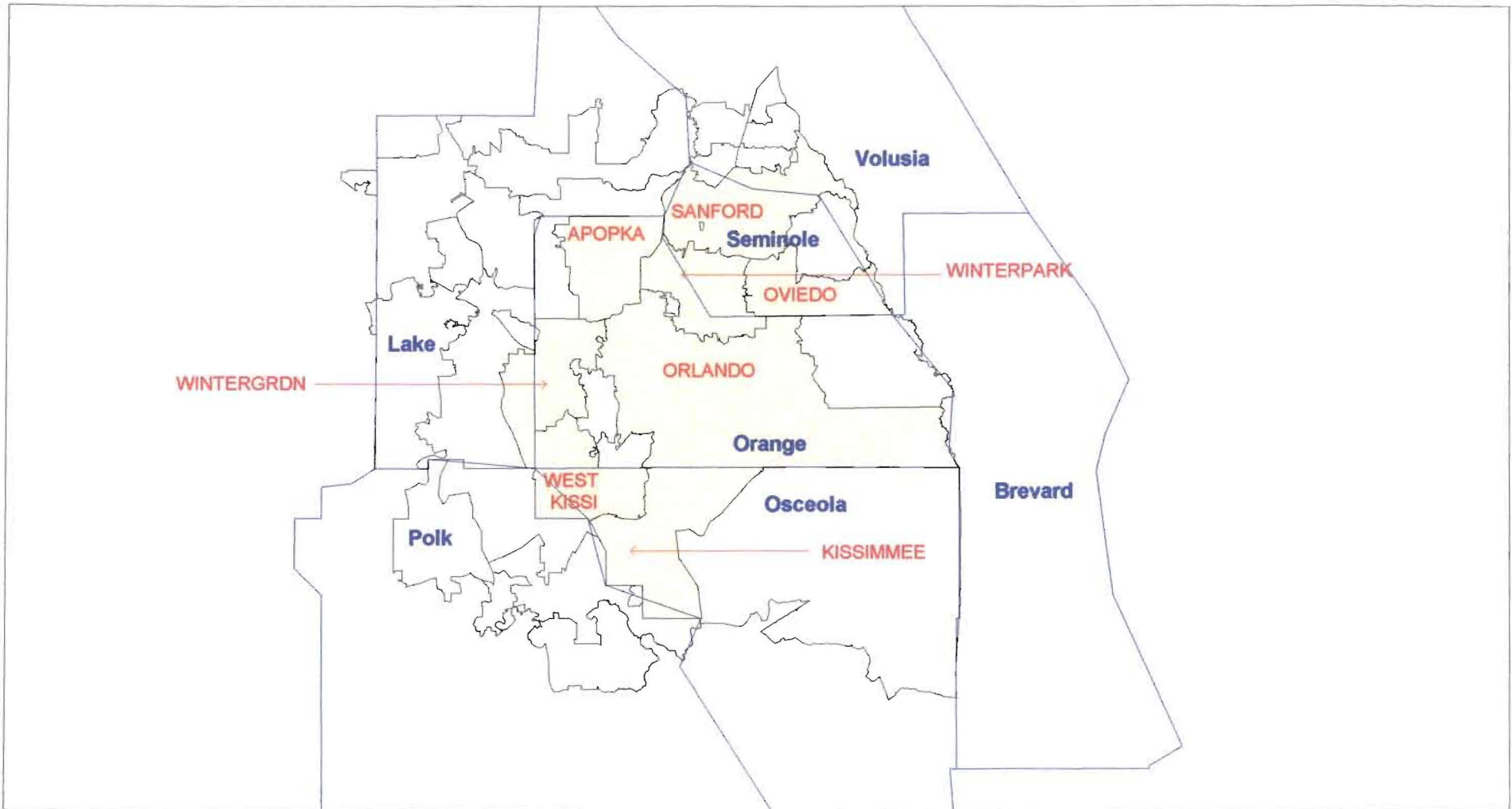
Jacksonville 911 Cnty Map

Cnty's - Blue

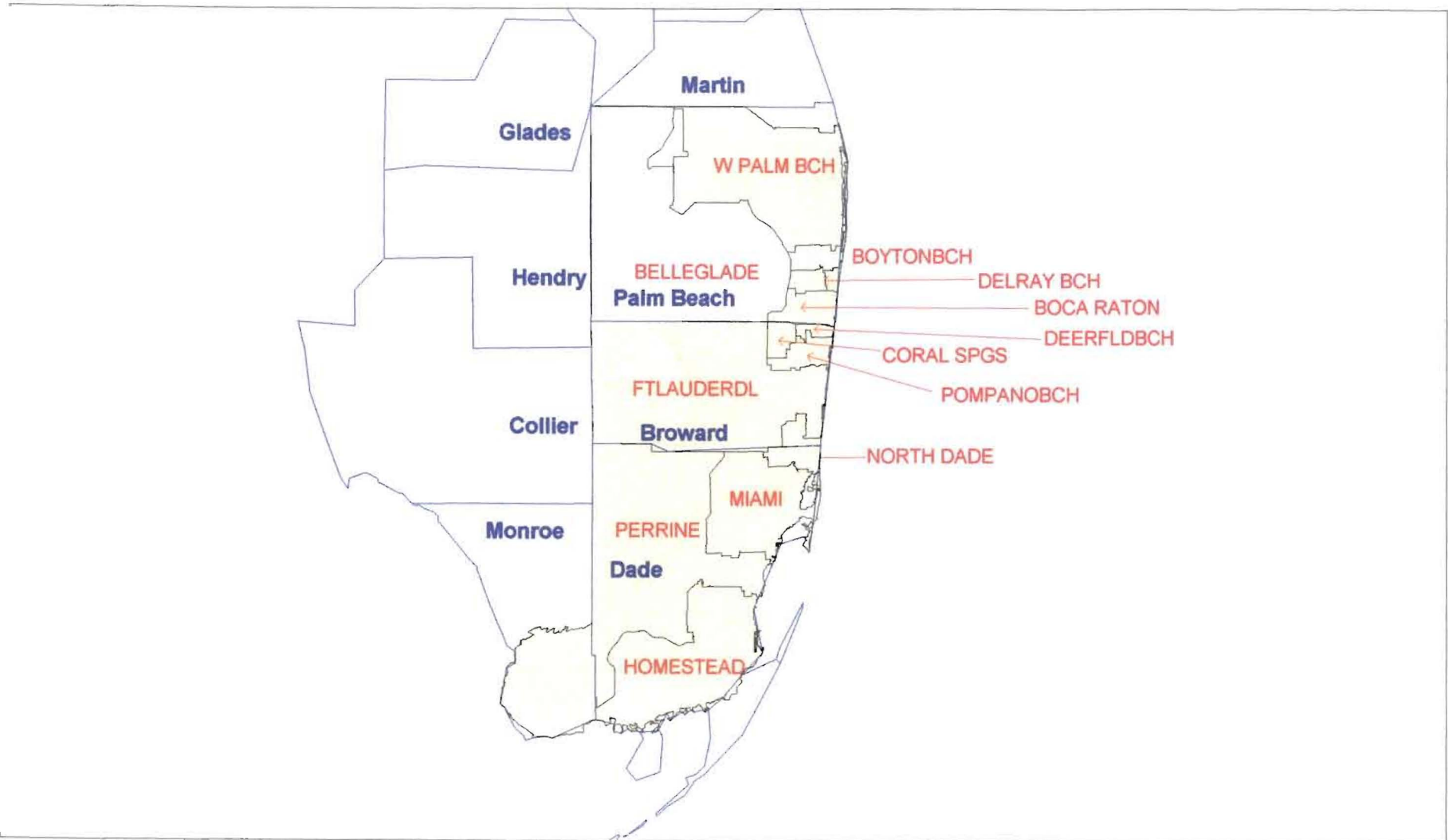
Orlando 911 Cnty Map
