**The Florida Competitive Carriers Association's and
The Telecommunications Resellers Association's
Request for Hearing**

The Florida Competitive Carriers Association (FCCA) and the Telecommunications Resellers Association (TRA), pursuant to 120.54(3)(c), Florida Statutes, hereby submit this request for hearing as described below. As grounds therefor, FCCA and TRA state:

1. Order No. PSC -00-0525-NOR-TP is a Notice of Rulemaking which actually contains multiple Notices of Proposed Rulemaking as attachments. In the Order itself at page 1, the Commission states: "*If timely requested*, a hearing will be held at a time and place to be announced in a future notice." (Emphasis added). Some of the attached Notices indicate that a hearing will be held *if requested*, while at least one Notice (appearing at pp. 25-29) indicates that a hearing *will* be scheduled.¹ Thus, some ambiguity may have been created in the Order.


2. Thus, in an abundance of caution, given the multiple Notices and any ambiguity that might result therefrom, FCCA and TRA request a hearing on proposed rules 25.4110(2) and (19) as they might pertain to ALECs (incorporated by rule 25-24.845) and IXC's (incorporated by rule 25-

24.490).

3. The Commission voted at the Agenda Conference where the rules were considered that proposed rules 25.4110(2) and (19) would *not* go into effect as they might pertain to ALECs (incorporated by rule 25-24.845) and IXCs (incorporated by rule 25-24.490) pending a hearing on those subsections. FCCA and TRA believe this is what is intended by the Notice of Rulemaking appearing at pages 25-29. Nonetheless, they file this request for hearing so as to avoid any ambiguity or lack of clarity in the record of this proceeding.

WHEREFORE, FCCA and TRA request a hearing as described above.
