COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and files its Notice of Intent to request a temporary waiver of the physical collocation requirements in the West Dade central office pursuant to Order No. PSC-99-1744-PAA-TP issued September 7, 1999.

1. BellSouth is unable to provide physical collocation in this office due to the lack of space. Currently, BellSouth has plans to complete a building addition in this office at the end of the second quarter of 2001. Once the addition is complete, there will be sufficient space to provide requesting ALECs physical collocation in this office.

3. BellSouth will file its petition for waiver 20 days from the date of this filing.


